Mayor Hauser called the Meeting to order at 7:30 pm.

Mayor Hauser led in the pledge to the flag.

Chief Grover noted that several suspects were rounded up as they have warrants and were brought before the judge.

Mayor Hauser asked if there have been traffic incidents relating to the islands. Chief Grover said that there are no official reports of any incidents. He sat and observed traffic on Main Street yesterday and did not see a problem. He has spoked with CID and with the Wyo. Co. Transit Bus Service.

#### **DPW REPORT** – presented by Supt. of DPW Ed Koziel

Supt. Koziel reported on the following:

- The lake level is 84". The gates were opened on January 10<sup>th</sup> to lower the lake in anticipation of warmer weather. Supt. Koziel noted that the level at the dam is not an accurate measure if the gates are open.
- 32 tree stumps were ground out. They will have top soiled and new trees planted in the spring.
- The waterline and hydrant were put in at the new headworks building at the Sewer Plant.
- One water main break was fixed on Lake Street.
- Two fire hydrants that were frozen were repaired.
- Christmas trees are still being picked up.
- · Potholes are being filled in.
- Going through a lot of road salt due to a lot of salt. 400 tons of salt have been used so far.
- Two main sewer plugs have been opened back up.

Supt. Koziel noted that he will go after sidewalks hard this spring.

# Tax Cap Override local law public hearing scheduled VILLAGE OF PERRY RESOLUTION

WHEREAS, all Board Members, having due notice of said meeting, and that pursuant to Article 7, §104 of the Public Officers Law, said meeting was open to the general public and due and proper notice of the time and place whereof was given as required by law; and

WHEREAS, Chapter 97 of the Laws of 2011 – "The Property Tax Cap" added section 3-c to the General Municipal Law which provides that the amount of real property taxes that may be levied by or on behalf of any local government shall not exceed two percent (2%); and

**WHEREAS,** in order to adopt a budget that requires a tax levy that is greater than the tax levy limit for the coming fiscal year, only if the Village Board first enacts, by a vote of sixty percent (60%) of the total voting power, a local law to override such limit for such coming fiscal year only; and

**WHEREAS,** the Village Board of the Village of Perry finds it in the best interest of the Village to hold a public hearing to consider the adoption of said local law.

NOW ON MOTION OF Trustee Draper which has been duly seconded by Trustee Billings, be it

**RESOLVED,** by the Village Board of the Perry will hold a public hearing on the proposed adoption of said local law on the 6<sup>th</sup> day of February 2017 at 8:00 p.m., at which time all interested parties and citizens for or against the proposed law will be heard.

WHEREAS, it appears to be in the best interest of the Village of Perry to prohibit Lance & Christine Lawton from continuing to be in violation of said section of Local Law No. 1 of 2007 of the Village of Perry; and

WHEREAS, the Village Board of the Village of Perry feels it is in the best interest of the Village of Perry to retain the services of Village Attorney, David M. DiMatteo, to pursue the enforcement of Local Law No. 1 of 2007 of the Village of Perry against Lance and Christine Lawton to ensure that this property comes into compliance with said Local Law.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor of the Village of Perry, be and he hereby is authorized and directed to retain the services of David M. DiMatteo, Attorney for the Village of Perry in this matter, upon such terms as he deems proper and advisable, and Mayor of the Village of Perry shall authorize David M. DiMatteo on behalf of the Village of Perry to take such action as may be deemed advisable to prevent any continuation of the violation of Local Law No. 1 of 2007 of the Village of Perry by Lance and Christine Lawton.

**PUBLIC HEARING** – Clerk Vosburg read the legal notice "The Village Board is considering a proposed local law entitled "The village of Perry Tree Law", which will provide for the regulation of the plating, maintenance and removal of trees within the Village of Perry which are on Village property or within the right-of-way of any public street. It is also the purpose of this law to establish and maintain diversity of tree species and maximize tree canopy through tree planting and preservation. Environmental significance of said local law will also be considered at public hearing."

Mayor Hauser introduced Dr. Zerbe from the Tree Board. Dr. Zerbe said that the Village Board is in charge of who is on the Tree Board and if the Tree Boar is not functional, then it comes back to the Village Board. Mayor Hauser read the 10 items that are the tree boards duties (from draft law). Clerk Vosburg asked how the enforcement is addressed. Mayor Hauser said that that the purpose is to not be a burden on the Village Board. The draft law states that the Zoning Officer and or the Police Department shall serve notice if a threat to trees is deemed to be imminent or serious. Mayor Hauser asked the clerk to work with the DPW committee to clarify items in the law with the attorney's office.

No one from the public spoke.

Motion by Mayor Hauser, seconded by Trustee Draper, to close both the public hearings at 8:30 pm. Motion carried with all voting aye.

Our names are Linda and Gary Smith, we live on Waltz Sub Tract, on the North end of Silver Lake, next to the Outlet Bridge. We are writing this letter in regards to the conditions on our end of the Lake, as I am sure you are all aware of.

Our tract consist of 10 properties, which in total covers 800 feet of water frontage. Every homeowner deals with the same problems, being that the sediment has built up to the point where no one can get their boats out onto the lake and are forced to rent space for their boats, so they can enjoy a ride onto Silver Lake.

We bought this property in 1990, and decided to relocate from the Village in 1998, there was great fishing and boating at that time and even though we are at the farther end of the tract, we did enjoy a little of the Lake view. Now we not only can't get out onto the lake, but also have to smell the sediment that has built up and see the weeds growing 5-6 ft. tall in front of our properties, which draw mosquitos and other insects to make it almost impossible to sit out on our Lakeside front yards.

Silver Lake is a valuable asset to all the local businesses, drinking water source to several towns, and could be a valuable tourist site, being so close to Letchworth Park, if it could only be dredged out and taken care of. I am hoping with everyone working on this project to see some results progressing to preserve our Great Asset to not only the Town and Village of Perry ,but also Castile and the surrounding towns.

On behalf our Tract negatively effected with the current condition of Silver Lake, please take into consideration the benefits we have addressed to dredging. If something isn't done to preserve this Lake everyone, including tourists, Village and Town of Perry, Castile, and all residents who are drawing water from the Lake, will loose.
