Alyssa Cutcliffe, PMO, was present to give an overview on the property maintenance program and her goals for the next three months. Trustee Jacobs asked if she could look at signs while driving around in the Village. Ms. Cutcliffe has taken an inventory on existing signs. OTHER BUSINESS

Mayor Hauser spoke about the Wyoming County Shared Services meeting that he attended, the third in a series. The two main targets of shared services are: county wide zoning and county wide assessing.

Mayor Hauser updated the board on the bridge replacement in Pearl Creek that is resulting in a truck detour though the Village. The 22 ton weight limit sign has been removed. The Wyoming County Highway Dept. would like to work with the NYSDOT as part of a shared services project. They believe that they can replace the bridge cheaper than the DOT.

Motion by Mayor Hauser, seconded by Trustee Jacobs, to open the public hearing on transferring of funds from the sewer reserve to the sewer funds up to the amount of \$51,825 for the Gardeau St sewer repair. Motion carried with all voting aye.

PUBLIC HEARING OPENED

The purpose is to transfer funds up to the amount of \$51,825 from the sewer reserve fund to the sewer fund for the repairs to the Gardeau St. sewer main. The Village budgeted \$20,000 to do the work in house, however, due the excavation depth and location and lack of manpower, it was decided to contract the work.

Supt. Kelly reported that WYCO will be starting tomorrow, September 5th.

TRUSTEE REPORTS

Trustee Billings reported on the following:

- Interviews for the part time clerk were today
- The Village is considering accepting credit card payments at no cost to the Village

Mayor Hauser reported that the county is looking at tax collection software and provide the license to the municipals at no cost. The estimated cost saving is \$500 - \$1000 each year.

Mayor Hauser announced that the first two interviews of four consultants selected for the interview process were held for the Public Beach Improvement Project.

Motion by Mayor Hauser, seconded by Trustee Matson, to close the public hearing at 8:10 pm. Motion carried with all voting aye.

Transfer of funds from sewer reserve to sewer fund approved – Motion by Trustee Billings, seconded by Trustee Matson, to approve the transfer of funds up to \$51,825 from the sewer reserve to the sewer fund for the repairs to the Gardeau St sewer line. Motion carried with all voting aye.

Mayor authorized to sign MOA with CSEA for allow for domestic partner coverage – Motion by Trustee Billings, seconded by Trustee Matson, authorizing the Mayor to sign the following Memorandum of Agreements:

- Village of Perry and CSEA General Unit for domestic partner coverage for health insurance
- Village of Perry and CSEA Police Unit for domestic partner coverage for health insurance
- Village of Perry and CSEA Police Unit to allow the School Resource Officer to work a split shift in necessary.

Motion carried with all voting aye.
