Mayor Hauser announced that the Village received a \$300,000 EPF grant for the Perry Public Beach Improvements. The Village did not received funds for the Market NY grant.

Mayor Hauser reported that at the last PMSA meeting, it was discussed if the Village should apply for a DRI program grant. He will check into this further with other partners within the county.

OTHER BUSINESS

No other business was presented for discussion.

Motion by Mayor Hauser, seconded by Trustee Draper, to adjourn the regular session and enter into executive session at 8:48 pm. Motion carried with all voting aye.

Motion by Mayor Hauser, seconded by Trustee Billings, to exit executive session and resume the regular meeting at 8:55 pm. Motion carried with all voting aye.

Resolution Authorizing sale of 10 N Main St

RESOLUTION OF THE
VILLAGE BOARD OF THE VILLAGE OF PERRY DECLARING LAND
AS SURPLUS PROPERTY SUBJECT TO PERMISSIVE REFERENDUM

Adopted: January 7th, 2019

WHEREAS, all Board Members, having due notice of said meeting, and that pursuant to Article 7, §104 of the Public Officers Law, said meeting was open to the general public and due and proper notice of the time and place whereof was given as required by law; and

WHEREAS, the Village Board of the Village Perry, pursuant to New York State Village Law, Article 9, §900, is authorized to, upon the adoption of a resolution, convey or lease real property in the name of the Village, which resolution shall be subject to a permissive referendum; and

WHEREAS, the Village Board of the Village of Perry has determined that the property owned by the Village of Perry located at 10 North Main Street which was formerly owned by Trestle Properties, LLC and thereafter surrendered to the Village of Perry for the intention of remedying the faults on the property pursuant to the progression of an ongoing zoning violation, is not needed for municipal purposes; and

WHEREAS, the said surplus property owned by the Village of Perry and located at 10 North Main Street is more fully described below:

ALL THAT TRACT OR PARCEL OF LAND situate in the Town and Village of Perry, County of Wyoming and State of New York, BEGINNING on the southeast side of Main Street in the Village of Perry at its intersection with the northeast line of the former "Duryea Block"; thence northeasterly on the southeast line of Main Street, thirty-five (35) links; thence southerly parallel with the northeast side of said Duryea Block to a point seventy-five and three-fourths (75 ¾) feet from said side Main Street aforesaid and one (1) foot deeper than said Duryea block; thence southwesterly parallel with the rear of said Duryea block, thirty-five (35) links to a point in the continuation of the northerly side of the Duryea Block, seventy-five and three-fourths (75 ¾) feet from Main Street and one foot from the back and of the Duryea Block; thence northwesterly along said Duryea Block seventy-five and three fourths (75 ¾) feet to the place of beginning; ALSO a right of way in the land or alley along the northeasterly side of premises, and subject to all rights heretofore acquired by others therein.

ALSO ALL THAT TRACT OR PARCEL OF LAND, situate in the Town and Village of Perry, County of Wyoming and State of New York, and bounded and described as follows:

BEGINNING at the southwesterly corner of lands now owned by Sarah A. Sweet Carston and situate on the southeasterly side of Main Street in said Town and Village (and being the same premises herein-above described); and running thence northeasterly along the southeasterly line of said lands hereinbefore described, thirty-five (35) links to the southeasterly corner of said lands of Sarah A. Sweet Carston; thence southeasterly and in continuation of the northerly line of said former Ezra D. Decker lands, twenty (20) feet; thence southwesterly and parallel with the first described boundary, twenty (20) feet to the place of beginning. ALSO hereby granting to the grantee, his heirs and assigns, a right of way to said premises for ingress and egress wide enough to drive teams loaded with wood or goods. Hereby intending to convey those certain premises and right of way as reserved in a deed by Ezra D. Decker and Angeline Decker, his wife, to one William B. Kingston bearing date the 21st day of January 1901 and recorded in the Wyoming County Clerk's Office, reference to which deed is to be had and is hereby made.

Intending to convey all of the lands and premises which are described in two certain deeds executed by Ezra D. Decker and Angeline A. Decker, his wife, as grantors, one of which deeds is recorded in the Wyoming County Clerk's Office in Liber 96 of Deeds at page 460; and other is recorded in said Clerk's Office in Liver 148 of Deeds at page 72.

SUBJECT to all right, title and interest, if any, of the public in and to any streets and roads abutting the above described premises to the center lines thereof,

SUBJECT to easements, restrictions, covenants and rights of way of record, if any.

BEING the same premises conveyed by Edward H. Rechberger, III to Trestle Properties LLC, by Deed dated July 23, 2010, and recorded in the Wyoming County Clerk's Office in Liber 740 of Deeds at page 502.

WHEREAS, the Village Board of the Village of Perry feels it is in the best interest of the Village of Perry to authorize the sale of said surplus property for fair and adequate consideration.

NOW ON MOTION OF Trustee Draper which has been duly seconded by Trustee Billings, now therefore

BE IT RESOLVED, that the Village Board of the Village of Perry authorizes the Mayor of the Village of Perry to, contingent upon the passage of the permissive referendum period required under law without a petition for a permissive referendum, to execute all documents necessary to sell said property; and be it further

RESOLVED, that the Clerk be and she hereby is directed to publish an abstract of this resolution concisely stating the purpose and effect thereof in the Village's official newspaper within ten (10) days after the date of the adoption; and be it further

RESOLVED, that said resolution shall not take effect until thirty (30) days after its adoption or until approved by the affirmative vote of a majority of the qualified electors of the Village of Perry.
