YMCA Soccer/Tennis Program

YMCA Soccer and Tennis Program agreements approved – Motion by Trustee Jacobs, seconded by Trustee Lapiana, to approve the agreements with the YMCA for the soccer and tennis programs and authorize the Mayor to sign. Motion carried with all voting aye.

PUBLIC HEARING SCHEDULED - EXPEND FROM CAPITAL EQUIPMENT

The DPW requested a Vacuum Excavator System in the 2019-20 budget, however, it was removed from the budget. There is a need for this item and the request is to fund it from the capital equipment reserve as discussed at the budget hearing.

Public hearing scheduled – Motion by Trustee Draper, seconded by Trustee Jacobs, to schedule a public hearing to expend up to \$70,000 from the Capital Reserve Fund for the purchase of a Vacuum Excavation System. Motion carried with all voting aye.

Trustee Reports

Trustee Jacobs reported that the Recreation Committee discussed paving of the park road, tennis courts repair and renaming the Village Park or Public Beach after the Perry Rotary Club to acknowledge their continued investment and commitment to the community.

Trustee Jacobs spoke on the Arbor Day celebration by the Perry Tree Board that was held on April 27th. Thirty people assisted with the planting of 14 trees.

Trustee Draper reported that the Perry Police Department received from the Wyo. Co. Sheriff's Department 10 portable radios and 4 mobile radios as part of a grant that the county received.

Mayor Hauser spoke on efforts to secure an electric vehicle charging station. The estimated cost of the equipment and installation for the station is approximately \$8,000. It would be located at the bottom of the festival plaza. Rebate for the cost of this project would be from NYSERDA.

Mayor Hauser announced that RFP's are out for the properties located at 58-60 and 59-61 South Main Street.

Motion by Mayor Hauser, seconded by Trustee Draper, to enter into executive session to discuss contract negotiations and the employment of a particular person at 8:34 pm. Motion carried with all voting aye.

Motion by Mayor Hauser, seconded by Trustee Draper, to exit executive session and resume the regular meeting at 8:55 pm. Motion carried with all voting aye.

Village Administrator authorized to sign MOA with the CSEA – PPD – Motion by Trustee Draper, seconded by Trustee Lapiana, to approve the MOA and authorize the Village Administrator to sign with the CSEA – Perry Police Department. Motion carried with all voting aye.

Jason Linderman appointed as Police Officer – Mayor Draper appointed Jason Linderman as a part time police officer as per the CSEA Contract. Motion by Trustee Draper, seconded by Trustee Lapiana to approve the Mayor appointment as presented. Motion carried with all voting aye.

2019 Seasonal Laborer appointed – Mayor Hauser appointed Benjamin Lepkowski as a seasonal employee at a rate of \$11.10 per hour starting May 13, 2019. Motion by Trustee Draper, seconded by Trustee Lapiana to approve the Mayor appointment as presented. Motion carried with all voting aye.
