MEMORANDUM OF UNDERSTANDING OR LGV COOPERATIVE AGREEMENT

This cooperative agreement is part of the Geotourism Initiative that promotes the region. **LGV Cooperative Agreement approved –** Motion by Trustee Jacobs, seconded by Trustee Lapiana, to approve the LGV Cooperative Agreement and authorize the Mayor to sign. Motion carried with all voting aye.

MARKET NY GRANT RESOLUTION

The Market NY grant application is being resubmitted from last year with an update that is is now a regional area, not just LGV.

Resolution adopted to submit the Market NY grant – Motion by Trustee Jacobs, seconded by Trustee Draper, adopting the following resolution:

VILLAGE OF PERRY RESOLUTION COMMITMENT TO PROVIDE THE LOCAL MATCHING FUNDS NEEDED TO FUND A LETCHWORTH GATEWAY VILLAGES SUSTAINABLE DESTINATION MARKETING INITIATIVE

"RESOLVED, that the Mayor of the Village of Perry, Wyoming County, New York, is hereby authorized as the official representative of the Village of Perry to execute and submit a Consolidated Funding Application for the Empire State Development Corporation Market NY grant program on behalf of the Letchworth Gateway Villages municipal collaboration for the Fiscal Year 2019 program, all understandings and assurances contained therein, and is hereby directed and authorized to act in connection with the submission of the application and to provide such additional information as may be required.

The Municipalities of Perry, Mount Morris and Geneseo in Wyoming and Livingston Counties have partnered to establish the Letchworth Gateway Villages (LGV) initiative to advance economic development and sustainable tourism in communities adjacent to Letchworth State Park in the Genesee Valley Region of Western, New York.

As the fiscal sponsor of the Letchworth Gateway Villages municipal collaboration, the Village of Perry hereby commits to providing a portion of the matching funds needed to expand the current LGV destination marketing initiative over the next two years (2020 and 2021) to additional rural communities in the Genesee Valley Region utilizing Market NY funding.

The Empire State Development Corporation Market NY grant program requires local matching funds equal to 30 percent of the cost of the program to be funded. A total of \$48,000 will be allocated from Letchworth Gateway Village's annual \$119,900 budget to provide the 30 percent match. The Village of Perry will be applying for the funding on behalf of the LGV initiative and partner communities.

Nicole Manapol reported that the proposed contract change is to have LGV billed monthly for actual use. She requested permission to sign as a signatory on the contract. WHEREAS, the Village of Perry would like to apply for a 2019 Target Area grant under the New York Main Street Program to renovate multiple mixed use buildings in the Downtown district; and

WHEREAS, municipalities in which New York Main Street projects are located are required to provide a resolution supporting the application for funding;

MRB Group has prepared two WQIP grant applications as part of the WWTF project upgrades. One would be for disinfection upgrades; the other grant is for wastewater treatment improvements.

Resolution of Support from the VILLAGE OF PERRY for the 2019 New York State Consolidated Funding Application, Water Quality Improvement Project

Wastewater Treatment Disinfection Improvements

WHEREAS, the Board of Trustees for the Village of Perry, located in Wyoming County, supports the submission of a 2019 Consolidated Funding Application (CFA) on behalf of the Village, for the Water Quality Improvement Project (WQIP) program, for disinfection upgrades to the wastewater treatment facility; and

WHEREAS, the New York State Department of Environmental Conservation (DEC) provides a competitive statewide reimbursement grant program for local governments, administered to directly address documented water quality impairments; and

WHEREAS, recent modifications to the Village's State Pollutant Discharge Elimination System (SDPES) Discharge Permit No. NY-0022985 added an effluent disinfection requirement and included a schedule of compliance for implementing an effluent disinfection process at the Village's Waste Water Treatment Plant (WWTP) located along Water Street Road; and

WHEREAS, findings in the Preliminary Engineering Report found ultraviolet disinfection to be the most cost effective means to implement effluent disinfection at the WWTP and recommended a capital improvements project which included the installation of ultraviolet disinfection tanks and equipment;

NOW THEREFORE BE IT RESOLVED, it is anticipated that the Village Board, on behalf of the Village, will complete the necessary actions to authorize expenditures for the proposed project, as well as authorizes Mayor Rick Hauser to execute necessary documents relative to and as required for the application; and

BE IT FURTHER RESOLVED, the Village Board does hereby accept that they shall provide at least 25% match of the total of any grant funding awarded, as a local match are hereby appropriated in the form of in-kind services, cash contributions and obligated from secured EFC Financing; and

BE IT FURTHER RESOLVED, that the Board of Trustees for the Village of Perry, located in Wyoming County, recognizes and fully supports the submission of the 2019 CFA for WQIP on behalf of the Village for improvements to the wastewater treatment plant.

VILLAGE OF PERRY Consolidated Funding Application

Resolution of Support from the VILLAGE OF PERRY for the 2019 New York State Consolidated Funding Application, Water Quality Improvement Project

Wastewater Treatment Facility Improvements

WHEREAS, the Board of Trustees for the Village of Perry, located in Wyoming County, supports the submission of a 2019 Consolidated Funding Application (CFA) on behalf of the Village, for the Water Quality Improvement Project (WQIP) program for wastewater treatment improvements; and

WHEREAS, the New York State Department of Environmental Conservation (DEC) provides a competitive statewide reimbursement grant program for local governments, administered to directly address documented water quality impairments; and

WHEREAS, the Village of Perry Wastewater Treatment Plant (WWTP) located along Water Street Road is listed on DEC's Waterbody Inventory/Priority Waterbodies List as a suspected source of pollutants in the Silver Lake Outlet and downstream waterbodies; and

WHEREAS, the DEC's *Genesee River Basin Nine Key Element Watershed Plan for Phosphorus and Sediment* lists the Perry WWTP as a high priority facility for phosphorus reduction; and

WHEREAS, flows to the WWTP have steadily increased and have been exceeding the permitted plant flows in the Village's State Pollutant Discharge Elimination System (SDPES) Discharge Permit No. NY-0022985, resulting in a Notice of Violation from the DEC; and

WHEREAS, findings in the preliminary engineering study recommended capital improvements to upgrade the WWTP to meet current design standards and increase the plant's design flow, including improvements to the trickling filters, installation of new settling tanks allowing for phosphorus removal, and upsizing all interconnecting site piping, greatly improving the water quality of the local and downstream waterbodies;

NOW THEREFORE BE IT RESOLVED, it is anticipated that the Village Board, on behalf of the Village, will complete the necessary actions to authorize expenditures for the proposed project, as well as authorizes Mayor Rick Hauser to execute necessary documents relative to and as required for the application; and

BE IT FURTHER RESOLVED, the Village Board does hereby accept that they shall provide at least 40% match of the total of any grant funding awarded as a local match are hereby appropriated in the form of in-kind services, cash contributions and obligated from secured EFC Financing; and

BE IT FURTHER RESOLVED, that the Board of Trustees for the Village of Perry, located in Wyoming County, recognizes and fully supports the submission of the 2019 CFA for WQIP on behalf of the Village for improvements to the wastewater treatment plant.

RESOLVED, that the Village is authorized and directed to agree to the terms and conditions of any required deed of easement granted to OPRHP that affects title to real property owned by the municipality and improved by the grant funds, which may be a duly recorded public access covenant, conservation easement, and/or preservation covenant; and

RESOLVED, that the governing body of the municipality delegates signing authority to execute the Master Contract and any required deed of easement to the individual(s) who hold(s) the following elected or appointed municipal office(s) or employment position title(s): Mayor and/or Village Administrator.
