VILLAGE OF PERRY VILLAGE BOARD MINUTES NOVEMBER 19, 2019

A regular board meeting of the Village of Perry was held at the Village Hall, 46 North Main Street, Perry, New York at 7:30 pm on the 19TH day of November 2019.

Mayor Hauser called the meeting to order at 7:30 pm and led in the pledge to the flag.

PUBLIC COMMENT

No one from the public spoke.

PRESENTATIONS

DON ROBERTS - WYOMING COUNTY ZONING

Don Roberts gave an overview of the county wide Zoning service. He explained how it started with a grant from the Genesee Finger Lakes Region Planning Council. As the grant guidelines, IMA's to join the county program were sent out to all municipalities in the county. Most of the towns have joined this county program as well as one village.

HEATHER BRIGGS - BONADIO GROUP

Heather Briggs – Bonadio Group – presented the draft financial statements and the communication letter to the board. She disclosed in the required communications letter that Bonadio did not encounter any difficulties in performing the audit. It was noted, in their unmodified opinion, that there were no material weaknesses and no significant deficiencies. There will be a couple of minor adjustments before issuing the final report. The last page of the handout was a comparison of the Village of Perry verses other villages in the state.

Motion by Mayor Hauser, seconded by Trustee Lapiana, to open the public hearing at 8:00 pm for the transfer of funds out of the sewer reserve to the sewer fund to purchase a tracked teleskid. Motion carried with all voting aye.

Public Hearing

The Village of Perry proposes to authorize the transfer of moneys, not to exceed \$79,500, from the sewer capital reserve fund to the sewer fund for the purpose of purchasing a new tracked teleskid.

No one from the public spoke.

LETCHWORTH CABLE ACCESS

Administrator Jensen reported that the Town of Castile and the Town of Perry have decided to continue LCA for one more year. They have compiled a list of expectations of LCA during the next year. Moneys from the savings will be used to balance the budget to cover the utility costs and rent for the studio. A new LCA agreement will be drawn up between the remaining three municipals – Towns of Castile and Perry and the Village of Perry.

SILVER LAKE TRAIL PROJECT/TAP

Administrator Jensen gave a brief update on the Silver Lake Trail (TAP)project. The committee reviewed the proposes that were received and interviewed four firms. The price proposal is within the budgeted amount.

Intent to Award for TAP project design approved – Motion by Trustee Jacobs, seconded by Trustee Lapiana, to proceed with the intent to award the design services to C & S Companies and enter into negotiations on a contract for the Silver Lake Trail (TAP) project. Motion carried with all voting aye.

Motion by Mayor Hauser, seconded by Trustee Jacobs, to close the public hearing at 8:20 pm. Motion carried with all voting aye.
