A regular board meeting of the Village of Perry was held at the Village Hall, 46 North Main Street, Perry, New York at 7:30 pm on the 16TH day of March 2020. The meeting was also available by phone.

Mayor Hauser called the meeting to order at 7:30 pm and led in the pledge to the flag.

PUBLIC COMMENT

Tracy Borek – resident on Gardeau St - read a statement expressing her displeasure with the Village's inaction to the farm truck traffic on Gardeau St. (statement attached)

Nate Osborne – owner/operator High Banks Dairy LLC – read a statement addressing the farm truck traffic and farming in general. (statement attached)

Mayor Hauser then read a prepared statement in response to the farm truck traffic. (statement attached)

Board members support the Mayor's statement on farm truck traffic – Motion by Trustee Jacobs, seconded by Trustee Billings, to support the Mayor's statement on farm truck traffic on Gardeau St. Motion carried with all voting aye.

PRESENTATIONS

TENTATIVE 2020-2021 VILLAGE BUDGET

Administrator Jensen reviewed the Tentative 2020-2021 Village Budget as presented to the board. The draft budget outlines a plan with no tax rate increase, maintaining a tax rate of \$15.25 per thousand. Revenues have increases by 3.28% over the current year to \$2,732,941. The Water Fund does not anticipate a rate increase; however, revenues are projected to increase 1.75% over the current year to \$758,200. This increase is due to the an increase in users. The Sewer Fund has a planned increase in revenues of 11.24% to \$926,800, as the second step of the sewer rate increase due to the WWTF improvement project would be implemented. Projects included in the General Fund include:

Final paving of the Village Park loop

- Street paving improvement projects
- Continued improvement to the storm drain system
- Commencement of the UPWP transportation system study for sidewalks on N Center St
- Critical tree removal throughout the Village
- Continued tree planting

Tentative 2020-2021 Village budget adopted and public hearing scheduled – Motion by Trustee Billings, seconded by Trustee Lapiana, to adopt the Tentative 2020-2021 Village Budget and schedule a public hearing for the budget at 8:00 pm on Monday, April 6, 2020. Motion carried with all voting aye.

Organizational Meeting scheduled – Motion by Mayor Hauser, seconded by Trustee Billings, to move the organizational meeting to Monday, April 20, 2020 at 7:30 pm. Motion carried with all voting aye.

COVID 19 UPDATE ON ITS IMPACT ON VILLAGE OPERATIONS

Administrator Jensen outlined protocols that will be undertaken by Village Staff concerning the COVID 19 virus. In-person customers will be limited to conducting their business from the hallway as the clerk's office door will be closed to the public; however, business can still be conducted through the mail slot on the hallway door. A drop box will be located in the hallway outside the village clerk's office if residents wish to drop off check payments. Police Chief Michael Grover advised the board of measures the police department are taking during this virus outbreak.

Mayor Hauser suggested that the Village update the Village's Business Improvement Loan program to loan small businesses funds to assist them paying rent, utilities, insurance, etc. He feels it is important to find ways for the Village to assist these important small businesses to keep this difficult time. He asked the Village Administrator to work with the Village Attorney to develop another facet to the BIL program. The Wyoming County IDA is also looking into possible ways to assist businesses. Board members are united is their desire to support the small local businesses during this difficult time.

Payment drop box and limited clerk's office accessibility plan approved – Motion by Trustee Lapiana, seconded by Trustee Jacobs, to limit in-person customers in the clerk's office and authorize the use of the payment drop box outside the village clerk's office. Motion carried with all voting aye.
