A board meeting of the Village of Perry was held at the Village Hall, 46 North Main Street, Perry, New York at 5:30 pm on the 1st day of February 2021.

Mayor Hauser called the meeting to order at 5:30 pm and led in the pledge to the flag.

2021-2022 DRAFT BUDGET

Samantha reviewed the first draft budget for the 2021-2022 fiscal year. The budget calendar was also reviewed. Salary amounts were projected and broken out into appropriate budget lines. Projected revenues were calculated. The property tax valuation went down from the previous year for the Town of Perry. Research will be done regarding this change.

GENERAL FUND

Larger budget items or lines that had a drastic change from the previous year were reviewed first. Police department vehicles were discussed. A plan was proposed to sell the 2013, 2014, and 2017 vehicles and purchase 2 hybrids and a Tesla. The plan would be to keep the hybrids for 3 years. The proposal for the DPW equipment line is to purchase a new dump truck to replace the 1993 truck and a new trailer to haul larger equipment. The plan would be to finance these over 5 years. Samantha reviewed NYCLASS balances for reserve accounts. DPW would look to outsource some work such as siding the maintenance building and having a bathroom installed. In the parks fund, the part time position filled by Steve Fuller would look to be increased from 25 hours to 40 hours per week.

WATER FUND

Revenues were estimated and interest was adjusted. Water plant upgrades were discussed. Elm Street requires water line replacement. Debt service numbers were received from Bernard P. Donegan and reviewed.

SEWER FUND

The storm sewer line was seen in the general fund and sewer. Debt service increased by about 30,000.

Motion was made by Trustee Draper to adjourn the budget meeting work session at 6:40 pm which was seconded by Trustee Lapiana, and carried with all voting aye

PUBLIC COMMENT

RESOLUTION PROCLAIMING THE MONTH OF MARCH TO BE COMMUNITY READS MONTH Jessica DeMarte spoke on behalf of Read Around Perry stating that they are sponsoring a community read event in March. The group is encouraging people to read the book "Nothing More Dangerous" by Allen Eskens. The author is planning a virtual discussion of the book on Tuesday, March 23rd at 6:30 pm. Read Around Perry is asking the Village of Perry to proclaim March as Community Reads Month. Mayor Hauser read the proclamation aloud:

TRUSTEE REPORTS

Trustee Jacobs gave an update from the Silver Lake Watershed Commission (SLWC) meeting. A map was handed out of the outlet and north end of the lake and Steve Perkins explained the latest on the dredging project.

The Silver Lake Trail Project Committee met for a budget discussion. The project is currently over budget by about \$60,000. The committee will look as places to make some cuts such as the area for parking on Walker Road. Millings can also be used in some areas rather than paving. The project should go out to bid in March.

Trustee Billings mentioned outreach from the Perry Community Garden. A proposal was written where the group is looking for a potential trust and agency arrangement. This will be discussed at the parks committee meeting and will be on the next board agenda.

Some discussion took place on appointing election inspectors. The board should look for a resolution on the next agenda.

PUBLIC HEARING REGARDING LOCAL LAW #2 - AMENDING CHAPTER 490

Mayor Hauser opened the public hearing at 8:00 pm regarding Local Law #2 - Amending Chapter 490. The proposal is presently on the County Planning Board agenda and on the Village Planning Board agenda for Thursday, the 4th. No comments were made from the public. The hearing was left open.

EXECUTIVE SESSION

Mayor Hauser made a motion to enter into executive session at 8:03 pm to discuss matters leading to the appointment of particular persons. The motion was seconded by Trustee Draper and carried with all voting aye.

Motion to exit executive session was made at 8:16 pm by Mayor Hauser, seconded by Trustee Draper, and carried with all voting aye.

PUBLIC HEARING REGARDING LOCAL LAW #2 - AMENDING CHAPTER 490

At 8:17, motion to close the public hearing was made by Mayor Hauser, seconded by Trustee Draper, and carried with all voting aye.

PUBLIC HEARING REGARDING THE POLICE COMMUNITY COLLABORATIVE PLAN

The public hearing was immediately opened regarding the Police Community Collaborative Plan. In summary, the plan exposed that there is a bit of a disconnect between law enforcement and mental health services. The Committee has recommended improvements. There are implicit bias trainings when officers are hired, but as an industry, no ongoing trainings. The plan is to recommend that plans and stats are reviewed annually. At the annual organizational meeting, a committee should be appointed to provide this update.

As no one else from the public joined or offered comment, at 8:25 pm Mayor Hauser made a motion to close the public hearing which was seconded by Trustee Draper and carried with all voting aye.

With there being no further business, motion to adjourn was made by Trustee Draper at 8:27 pm, which was seconded by Trustee Lapiana, and carried with all voting aye.
