PUBLIC HEARING – ROCHESTER'S CORNERSTONE GROUP – 165 LAKE STREET

The public hearing was opened at 6:40pm. No one from the public was present to comment. An application was previously submitted by Rochester's Cornerstone Group for Silver Lake Meadows, 165 Lake Street, for site plan improvements including lighting, landscaping, sidewalks, parking lot and drainage. The final site plan was previously approved on July 30, 2020, but because no work has started, the permit expired according to the zoning law. Rochester's Cornerstone Group has an application into the state for funding of the rehab work, but an active permit is required for approval, as the state wants to see "shovel-ready" jobs.

Ryan Brandt of Rochester's Cornerstone Group provided some details of the plans stating that the property has physical needs for improvements. The parking lot has many potholes and new curbs are needed. In reconstructing the parking lot there will be an addition of a stormwater

system. Accessibility improvements are also needed to bring the property up to current guidelines.

There are no changes to the original plan other than eliminating the addition of a community center attached to the laundry facility. The majority of the work will be uniform across all apartments and there are plans to hire a relocation specialist to assist with any transitions. Funding will be awarded in October or November of this year, so if awarded, work would not be scheduled to start until next spring.

The public hearing was closed at 6:55pm. Motion to approve the final site plan was made by Todd Mack and seconded by Tim Cipolla. The motion was carried with the following vote:
