HALLOWEEN CELEBRATION!

Halloween will be celebrated on Monday, October 31st. Trick or treating is from 5pm-9pm. The Police Dept. will provide continuous surveillance of the Village.

BULK LEAVES AND BRUSH PICKUP

Brush and bagged leaves pickup are finished for the year.

Bulk leaf pick-up will begin the week of October 24th.

Please rake leaves near the curb but not in the streets.

- Do not pile up around fire hydrants, trees, or poles.
- Please do not put grass cuttings, branches, or garden debris in with the bulk leaves.
- Leaves in plastic garbage bags will not be picked up.
- Please do not rake leaves, stones or grass cuttings into the street or catch basins.

WINTER PARKING BAN

No parking is permitted on village streets from November 1st to May 1st between the hours of 2am and 6am. All cars left parked on the streets between these hours will be ticketed. In the event snowplows are working, all cars parked on village streets will be towed at owner's expense.

GARBAGE POLICY

Garbage and recycling totes are to be placed near the roadway for pickup on the day before or day of pickup only. Since 4/1/2021 the Village has been enforcing chapter 465 section 14 of the Village Code (which can be found at www.villageofperry.com). Removal of garbage by the Village will result in fees. SCAM ALERT

The Village Police Department wants to remind residents that no police department will solicit for money. Recent scams include text messages for police departments selling t-shirts and hoodies. This is a scam. If you receive a message like this, just delete it.

REMINDER OF SNOW REMOVAL

While the Village has historically plowed sidewalks as a courtesy to our residents, please remember that it is ultimately a resident's responsibility to keep sidewalks clean and clear of snow and ice. The Village's first priority is to clear the roads for emergency vehicles. The second priority is vehicle access for the general public. Then, the Village plows the sidewalks from the school outward.

Please clear away the snow around fire hydrants.

Remember to not push or throw snow or ice onto road surfaces. New York State Law prohibits such actions.

UPDATE FROM DEPARTMENT OF PUBLIC WORKS

The Department of Public Works is wrapping up their paving year with Water Street completed on 10/21 and Elm St. completed on 10/25. Elm Street underwent a lengthy but much needed process of a sewer main repair and a new water main that has allowed better pressure to the resident's homes as well as an additional fire hydrant and stronger pressure in the case of an emergency. Also paved this year were Fruit St, Genesee St, and E. Genesee Street. Walnut Street is scheduled for paving in Spring of 2023.

The Village has received a \$672,500 grant to upgrade the drainage and repair catch basins on Hawthorne/Benedict/Olin/Watkins which is scheduled for Summer of 2023, with paving to follow.
